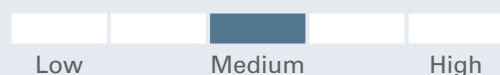
Investment objective

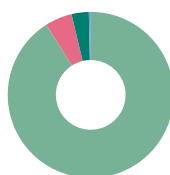

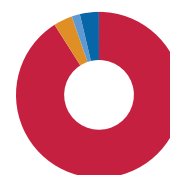

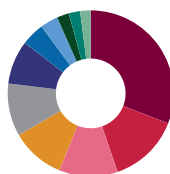
